EXPLANATORY NOTE:

1. This application need only be completed if you intend to supply or expose for supply fireworks outside of the following periods:
 - on the first day of the Chinese New Year and the three days immediately preceding it;
 - on the day of Diwali and the three days immediately preceding it;
 - during the period beginning on the 15th October and ending on the 10th November; or
 - during the period beginning on the 26th December and ending on the 31st December.
2. The London Borough of Bexley may refuse to grant a licence, or may revoke a licence that it has granted, if the applicant has committed any of the offences mentioned on the application form.
3. If a licence is refused or revoked the applicant may appeal to the court against the decision. That appeal must be made within 28 days of the decision being notified to that person.
4. This authority is under a duty to protect the public funds it administers, and to this end may use the information you have provided on this form for the prevention and detection of fraud. It may also share this information with other bodies responsible for auditing or administering public funds for these purposes
5. The information gathered in this form may constitute personal data as defined in the Data Protection Act 1998. Any personal data will be processed in accordance with the requirements of that Act.
6. Please note that it is an offence under section 33 of the Health and Safety at Work etc Act 1974 to provide false information. Incomplete or inaccurate information could result in a delay in processing your application.
7. Every separate premise where fireworks are kept, is also required to hold a Certificate of Registration or Store Licence in accordance with the Manufacture and Storage of Explosives Regulations 2005. Please contact the Licensing Team for further advice and guidance.
8. Fireworks must not be sold to persons under the age of 18.
