Important: Final data submission will be conducted via a website, not this template. This template is intended to help you prepare for the data submission website, including for its data validation conditions. DHSC is currently developing an online portal where local authorities will submit their Fair Cost of Care exercise results, reports and Market Sustainability Plans.

Using an online portal improves data protection and security compared to submitting an Excel template via a less secure email inbox.

An online portal will also significantly reduce the likelihood of error or need for resubmissions, in addition to reducing the resource required to process and analyse the returns.

Details regarding how to submit Fair Cost of Care data to the portal will be shared at the earliest time possible in advance of the 14th of October deadline. Certain data validation conditions will be built into the portal. For example, local authorities will not be able to submit their return if they have entered negative numbers into cells.

Whilst FCOC data returns should be entered using the online portal, familiarisation with the new version of Annex A is encouraged as preparation in case of technical issues with the portal and since the same data validation checks that will be present in the portal have also been built into the new version of Annex A. These data validation checks are set out below. We recommend that local authorities test their return by entering their data into this Annex A template ahead of their portal submission.

If their return meets all the compulsory conditions below then they will be able to submit successfully to the portal.
