- Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer in the borough where the elector is registered by 5pm on Wednesday 17 April 2024. - Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer in the borough where the elector is registered by 5pm on Wednesday 24 April 2024. Applications can be made online: www.gov.uk/apply-for-photo-id-voter-authority-certificate.
- 8. Applications to vote by proxy at this election must reach the Electoral Registration Officer in the borough where the elector is registered by **5pm on Wednesday 24 April 2024.** Some applications can be made online: <u>www.gov.uk/apply-proxy-vote</u>.
- 9. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer in the borough where the elector is registered by **5pm on Thursday 2 May 2024.**
